Gunner Wallace Brunt



On the **20 August 1941**, K73619 Gunner Wallace Reece Brunt, a member of 85 Bty, 15th Coast Artillery Regiment, was drowned in the waters of Sunderland Channel near Yorke Island. Gnr Brunt and Gnr Hough were attached for the day to assist with the tow of a water scow and a punt that was being filled with materials by some RCE soldiers at the beach closest to the water collection point on Hardwicke Island. They were to travel with the towboat, York, to drop off the water scow and, while it filled, assist with towing the punt back to Yorke Island. Brunt and Hough rode on the York while the Engineer soldiers rode in the punt.

As the York entered Paterson Rip, the punt started to take on water in the waves. Brunt and his comrade, at the direction of the skipper conning the York, started to short up the tow line to get the punt soldiers to the York safely. As the punt reached the York, those aboard the vessel started pulling those on the punt to safety. At that point, the punt sank, pulling the towline off the York. By chance, Brunt had his foot in a bight of the towline, was snagged and dragged overboard. Brunt grabbed Hough as he went overboard, who injured his shoulder in the attempt to save him but was unable to hold on. His body was never recovered.

Gunner Brunt joined the Canadian Active Service Force on 16 December 1940. He had served in the Non-Permanent Active Militia (NPAM) as a member of The Duke of Connaught's Own Regiment from November 1932 until March 1933. In the civilian world, he had been seaman, a cannery worker and a steward. He married Anne on 8 October 1938, and they had two daughters Sharon and Bonita. He was also survived by his father, John Brunt, and brothers John(RCAF), Billie(RCAF), Leslie, Vincent, Walter and Ray.

On numerous occasions during the past number of years Ted Hawthorne swaps his BC Regiment beret for his lawyer's cap to assist Royal United Services Institute Vancouver Society (aka RUSI Vancouver). He is present at Annual and General Meetings, files required documentation under the **Societies Act** of BC, and generally guides and advises the RUSI Board of Directors when necessary. In 2010, he helped guide RUSI Vancouver through the process of

rewriting its Constitution and Bylaws and registering the Society under the BC Societies Act. For his contributions at that time, Ted Hawthorne was appointed Special Counsel to RUSI Vancouver in 2011 and, more recently, was presented with a RUSI badge plaque by an appreciative membership. This past month Honorary Colonel Hawthorne was again helpful with RUSI Vancouver's administrative affairs. To show its continuing appreciation, Col Ted was presented with a bottle of Glenlivet 12-year old malt Scotch whiskey by Cam Cathcart, President of RUSI Vancouver, on behalf of its members. He graciously accepted the whiskey, which took place following the 76th Anniversary Commemoration of the 28th Armoured Regiment (The BC Regiment) at Hill 140, on 9 August at St Julien Square in Vancouver.

Dawn Patrols in Australia Over Orroral Valley Fire

A new era of dawn patrols has arrived in the Australian Capital Territory with the deployment of Army Small Unmanned Aerial Vehicles to monitor spot fires during the early morning hours when conventional aircraft are preparing for the demanding hours ahead. Integrated into the extensive ACT Emergency Services Agency's intelligence collection capabilities, the small reconnaissance aircraft are fitted with an infrared video camera which is ideal for looking into the heart of a spot fire. The Wasp III Small Unmanned Aircraft System, a light-weight air platform that provides beyond-line-of-sight imagery, is being used to observe the Orroral Valley fire.

The aircraft is equipped with two on-board cameras to provide real-time intelligence to its operators, and its small size makes it easier than larger unmanned aircraft to integrate into the air movements coordination that is necessary in modern firefighting. Gunner Scott Fressand, of the 20th Regiment, Royal Australian Artillery, is a team member operating the Wasp III over the burning slopes of Mount Tennant, near the village of Tharwa in the south of the Australian Capital Territory. He said the system was normally used at the tactical level for tasks such as providing imagery of what is over the next hill. "For this operation we've been watching the fire

and looking for spot fires, which can be concealed by smoke,” he said. “Then we relay the information to our headquarters. It’s been great to help, and it’s a valuable tool to use at a time of day when other air assets aren’t available.”

In 1918, a member of the Canadian Expeditionary Force was awarded the Victoria Cross—but he wasn’t Canadian at all. In fact, Lieutenant Thomas Dinesen was from a wealthy and influential Danish family. He had graduated as a civil engineer in 1916 and wanted to enlist. Although he had served in his country’s army reserve, Denmark was neutral in the First World War. His military ambitions were also frustrated by Britain, France and the United States: all turned him away when he attempted to enlist. While in the US, he came across a Canadian

recruiting poster (as many as 40,000 Americans joined the CEF). Although unfamiliar with Scottish-Canadian culture and knowing only a few words of English, he was welcomed into the Canadian army and transferred to the Royal Highlanders of Canada. He later wrote that at first he couldn’t understand why his Regiment had been named for a black watch. He was sent to France in March 1918.

He was experienced in battle by the time his battalion was assigned, on Aug 12, to clear the maze of enemy trenches near Parvillers, where the Canadians were being held up by wire between the trenches. His company's task was to bomb the German front and support trenches. They met stiff resistance. "The Germans were hardly demoralized," wrote Robert Smol in a 2017 article for *Esprit de Corps*, noting the battalion's operations report said the enemy "fought with determination and in many cases the attack was pressed home with the bayonet." Dinesen, then a private, single-handedly put machine guns out of action. Throwing a dozen or so Mills bombs and using his bayonet, he killed at least a dozen enemy. "I turn a corner quickly—two grey Germans stand straight in front of me...Two red flashes straight into my face...but they haven't hit me, so now it is my turn," he wrote in his memoir, quoted by Smol. "A snap-shot at one of the two, and the other disappears round a corner.... At the next corner a shower of rifle bullets and 'sticks' whizz past my head from a machine-gun post.... I fire away madly till my magazine is empty; then I fling down my rifle and hurl my bombs at them...and then we reach the next machine-gun post and throw ourselves against it, yelling and roaring, with bombs and bayonets, battle-mad...."

King George V invested Dinesen with the Victoria Cross in December 1918 for "most conspicuous and continuous bravery displayed during ten hours of hand-to-hand fighting, which resulted in the capture of over a mile of strongly garrisoned and stubbornly defended enemy trenches," says the citation. "Five times in succession he rushed forward alone, and single-handed put hostile machine guns out of action, accounting for twelve of the enemy with bomb and bayonet. His sustained valour and resourcefulness inspired his comrades at a very critical stage of the action and were an example to all." He was appointed lieutenant before the end of the war and after hostilities ceased, joined his celebrated sister Karen Blixen, author of *Out of Africa*, on her farm in Kenya before also launching a career as a writer. His memoir *Merry Hell: A Dane with the Canadians*, was translated into English in 1930.

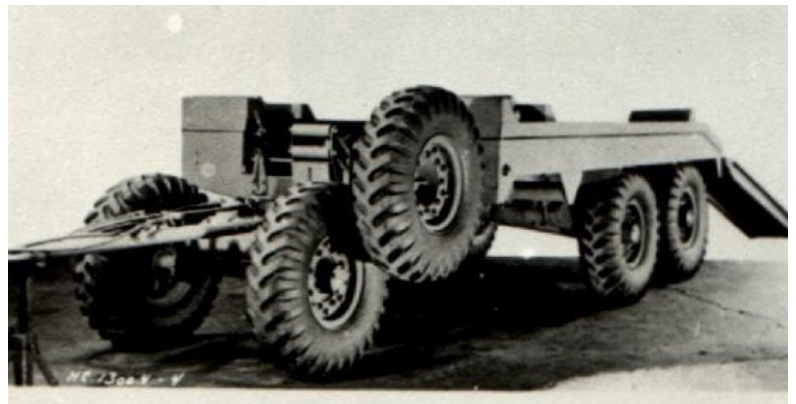

The Canadian Rangers: Cornerstone for Community Disaster Resilience in Canada's Remote and Isolated Communities.

The Royal United Services Institute of Nova Scotia extends an invitation to members of your association to hear a video-conference presentation by Dr Peter Kikkert, Irving Shipbuilding Chair in Arctic Policy, Brian Mulroney Institute of Government, St Francis Xavier University, titled "The Canadian Rangers: Cornerstone for Community Disaster Resilience in Canada's Remote and Isolated Communities." Dr Kikkert's bio is at <https://bmig.ca/kikkert/>.

The involvement of the Canadian Rangers in the broader response to COVID-19 highlights a role that they have been playing for decades: by virtue of their presence, capabilities, and the relationships they enjoy with(in) their communities, Rangers regularly support other government agencies and are often at the forefront preparing for, responding to, and recovering from a broad spectrum of local emergency and disaster scenarios. This talk will explore how the Rangers strengthen the disaster resilience of their communities, suggest how to enhance their impact, and argue that the organization could serve as a model for how targeted government investment can build resilience in similar jurisdictions.

The talk will start at 1 pm Halifax time (1:30 pm St John's, noon Ottawa, 11 am Winnipeg, 10 am Calgary, 9 am Victoria), Wednesday, 19 August, then be followed by Q&A and finish by 3 pm Halifax time.

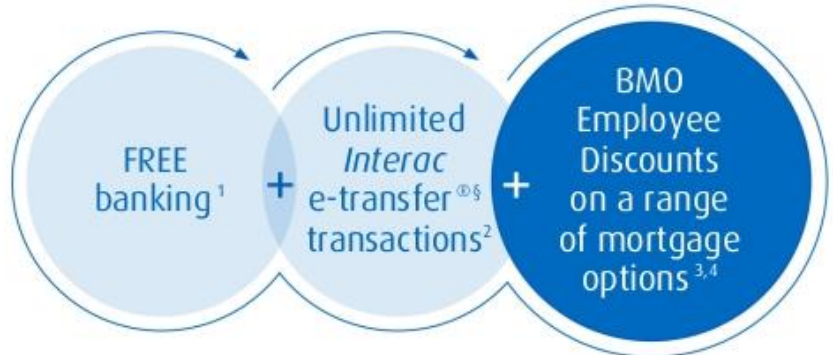

BMO and the Canadian Forces Morale and Welfare Services have teamed up to offer the CDCB Program to eligible members of the defence community and their families.

Who is eligible for the CDCB Program?

Program benefits are exclusive to regular force personnel, reserves, recruits, military families, veterans and retirees, as well as Department of National Defence (DND) and Staff of the Non-Public Funds civilian personnel, the RCMP and the Canadian Coast Guard.

Can BMO help me if I am relocated or deployed?

One way BMO can help is by covering your prepayment charges when you are relocated or deployed through the Integrated Relocation Program, and have to move or break your mortgage.

How do Canadian Forces Morale and Welfare Services (CFMWS) get funded by the BMO Support Our Troops MasterCard[®] program?
