6. CANTEN COMMITTEE 1. A meeting is called for 1900 hrs tonight in the Mess Hall, for the purpose of electing 3 members to the Canteen Committee which will function for the following twelve months.

2. The Canteen Committee is to consist of one Officer detailed by the Officer Commanding York Island, namely Lieut. R.F. Osburn, and two other ranks, (one of whom shall be a Bombardier) to be elected by the members of the 85th battery, and one other rank, to be elected by members of attached units, so one above the rank of bombardier or corporal shall be eligible to vote at such an election. 3 To facilitate voting, members of the 85th. Battery will occupy the south side of the Mess Hall, and members of attached units will occupy the north side. 4. The committee so elected will meet on Thursday 17th. March at 1900 hrs at a place to be decided

FIRE PROTECTION

1. Replying to D.A. & Q.M.G. circular of 23rd February, 1940 File (V 53-1-1)
2. The protection for this camp consists of the following:-
 - (a) Five buckets
 - (b) Four fire extinguishers
 - (c) Two fire pumps, and 2000 lineal feet of hose borrowed from the Forestry Department of the Province of B.C. Both the pumps and hose have to be returned to the Forestry Department early in April.
3. After April 1st the only protection will be the fire buckets and fire extinguisher which will be entirely inadequate to put out a fire of any size.
4. In addition the Island is covered with windfalls, slashed trees, etc., and we will almost certainly have a forest fire on the Island during the dry season, as with over 150 men employed on the island, there will be numerous cases of matches and cigarette stubs being thrown away by careless smokers.
5. The hazard is particularly bad around the fort where all the trees were felled two years ago by the contractors in order to give a field of fire, but no attempt was made to burn the slash or fallen timber which is now dried out.
6. The limited number of men available in the garrison have cleared the actual camp-site and most of the site of the fort, but it is absolutely impossible for them to clear the rest of the island before the dry season commences.
7. While the wire fence was being built round the fort in September the civilians started a small fire which spread rapidly and nearly involved the fort before it was brought under control.
8. It is proposed to establish one or two tanks capable of holding 10,000 gallons of fresh water for domestic purposes, but this will be insufficient to put out a really serious fire.
9. This matter was brought to the attention of the following:-
 - (1) H.C. M.D. 11 by letter October, 1939.
 - (2) The Dist. Officer (Major J.G. Rycroft, R.C.A.) was informed of it in November, 1939, and said he would report it.

- (3) District Hygiene Officer, December 1939, who stressed the matter in his report.
 - (4) The D.F.O. was personally informed by me about December 28, 1939.
 - (5) The danger was personally drawn to the attention of Lieut. Cunningham, R.C.E. in January, 1940.
 - (6) The District Officer (Lieut. Wingert) advised he will report on it.
11. It will be necessary to employ at least 50 men for over two months to cut and pile the best timber for firewood and burn the remainder. The firewood should be kept as much as possible in order to save expense to R.C.A.S.C. in forwarding firewood later. The season for burning slash ends on April 30.
 12. It will also be necessary to supply fire pumps and hose capable of reaching any part of the island. There is plenty of sea water available for fire fighting but no pumps or hose.
 13. If this is not done before May the Department of National Defence will have to build a new fort and living quarters before September 1940.

6. PERMISSION TO MARRY.

A soldier who has been granted permission to marry, will, as soon as practicable after the marriage, hand in the Marriage Certificate to his Commanding Officer, in order that the necessary notification of the marriage may be published in the Daily Orders Part II. A certified copy of the Marriage Certificate, together with a certified copy of the Daily Order Part II, shall be attached to the M.F.M.16. (Application for Dependents Allowance) completed by the soldier, after which the Marriage Certificate will be returned to the soldier.

7. TRADESMEN TESTS FOR THE PERMANENT ACTIVE MILITIA.

Officers Commanding Units are advised that copies of Tradesmen Tests for the Permanent Active Militia, 1937, are in the course of preparation at District Headquarters, and will be issued to Units as soon as they are available.

8. CONDUCT SHEETS. (a) H.F.M.6. "Field Conduct Sheet" is the only conduct sheet to be maintained by members of the C.A.S.F. consequently Regt. Conduct Sheets and Company Sheets (see K.R.(Can) 1518 and 1523) will not be kept.
- (b) The conditions governing Field Conduct Sheets are outlined in K.R.(Can) 1527.(a),(b),(c) and (f). The conditions of K.R.(Can) 1527.(d) and (e) do not apply to the C.A.S.F.
- (c) Field Conduct Sheets will not be destroyed in accordance with K.R.(Can) 1524. The original Sheet will be maintained for the full period of the individual's service. Sheet 2 will be raised for continuation, when space for entries is not available on the original, but neither may be destroyed.
- (d) The ultimate disposal of a Field Conduct Sheet is governed by C.A.S.F. Routine Order 3815) not the last sentence of K.R.(Can) 1527.(e)

9. DRESS. The attention of all Officers Commanding is directed to the following:-

- (i) Officers and all other ranks will attend all public functions in uniform.
- (ii) ~~Mufti~~ may be worn by Officers and Other Ranks for recreational purposes while on leave and at functions of a strictly private nature.
- (iii) When uniform is worn, it must be in accordance with Dress Regulations as promulgated in District Routine Orders from time to time.
- (iv) The collars of tunics, also greatcoats, when worn, must be properly buttoned up. This also applies to blouses of Battle Dress.
- (v) The Field Service Cap must be worn at the correct angle, i.e. the front of the cap should be over the centre of the

forehead, one inch above the right eye, and just touching the right ear.

(vi) Troops at all times, and particularly so in public places must be properly dressed, and carry themselves in a smart and soldier like manner. The practice of troops walking around with their hands in their pockets must cease forthwith.

10. ABSENCE WITHOUT LEAVE.

(a) It has come to notice that there quite a number of cases of personnel being absent without leave for short periods.

(b) Officers Commanding all units are to impress upon all concerned that this offence will not be tolerated and offenders will be severely dealt with.

(c) Troops must be made to understand that absence without leave even for a short period, is a serious breach of military discipline and is not conducive to the maintenance of proper discipline.

11. CHANNELS OF COMMUNICATION.

All requests for Transfers, Postings, Discharge etc, must be made through the correct Channels of Communication, which is through the Unit Commanding Officer

BRIS TO BOUND

1. About 2150 hrs on 4th March, 1940, the examination vessel was in Sunderland channel examining a vessel when another vessel passed along Johnston Straits.
2. The Examination vessel signalled it to stop several times, then fired a red very light as a stop signal.
3. The vessel failed to stop as the fort was signalled to stop the vessel.
4. No. 2 Gun fired one round at 2202 hrs, at 3200 yards across her bow.
5. The vessel failed to stop as the examination vessel signalled the fort to fire again.
6. No. 2 Gun fired two more rounds before the vessel stopped and headed back toward the examination vessel.
7. The Examination Officer dealt with the case. I am informed that the vessel was H.V. Shrimp of Wrangell, bound for Seattle.

DETACHMENT 2nd. Bn. (MG) Can. Scots. Regt.

1. This detachment is due for relief on March 18, 1940, as they arrived on December 18, 1939. Will you please arrange for them to be relieved.
2. In connection with this relief will you please ask O.C. 2nd Bn. to see that the two N.C.O.s (Sergeant and Corporal) are picked men, capable of maintaining discipline in the detachment. I have had to send down two men, Sgt. Kerton and Cpl. Fleming in the previous detachment as useless. The Sergeant, in addition to being a good disciplinarian should be a good MG instructor, as the detachment should continue training as machine gunners.

MEDICAL INSPECTION

1. The previous detachments came up without any medical inspection. On arrival one of the last detachment was found to be infected with crabs and two were sent down with suspected venereal.
2. In addition, three men were sent down to Vancouver for dental treatment. Three more men should go down for dental treatment, but are being held until relief.
3. If a proper medical and dental examination had been made prior to leaving Victoria, the expense of transportation would have been saved.

UNIFORMS

1. The last detachment only had five kilts among fourteen men; the remainder being sent up dressed in sweaters and trousers service (one pair), with only one suit of summer underwear. One man had only a pair of boots worn through at the toes.
2. I have issued to them two suits winter underwear, one pair trousers service, etc., and am trying to obtain an issue of battle dress so that they can pass through Vancouver decently clothed.
3. I would request that the next detachment be sent up properly clothed and equipped, as this station is no place to send men inadequately clothed.

6. INTERIOR ECONOMY -- In future the practice of detailing personnel daily for hut orderly duties will be discontinued.

The H.C.O. i/c of each barrack room will establish a roster providing two men each day--one to attend to the fires, and one to sweep out the barrack room each morning.

Each man will be responsible that the area around his own bed (or in the case of vacant beds due to personnel being on leave--an area to be decided by the said H.C.O. i/c) is swept to the middle of the floor before breakfast each morning. The man detailed as per roster will be responsible that the centre of the hut is swept clear fifteen minutes before the parade hour.

Cigarette ends, matches, etc., must not be thrown on the floor of barrack rooms. Tobacco tins can be used as ash trays.

Each week, as weather permits, a period will be devoted to interior economy; i.e. airing of blankets and scrubbing out barrack rooms, etc.

Page two

A box or other receptacle is to be maintained in each barrack room for the disposition of cigarette cartons, paper, etc. The man detailed for sweeping each morning will be responsible that this container is emptied as required.

CANTEEN -- Boxes have been provided for the reception of cigarette boxes, chocolate bar wrappers, etc. These latter must no longer be thrown on the floor of the Canteen or along the walk outside the building. Personnel disregarding these orders will be strictly dealt with.

ABLUTION HUT - Bowls provided in this hut are not to be carried away.

HYSS -- All ranks are warned against wasting food. No man should take on his plate more than he can eat. If he does not want any portion of the food, he should so state before being served. If he needs a second helping he can go back for it.

All ranks must appear with clean hands and face and hair brushed.

MARKING OF CLOTHING All ranks are required to mark all items of clothing and equipment with their Regimental number and, where possible, their name, immediately.

CANTEEN PURCHASES

1. Effective 1st March, the Canteen is placed on a cash basis. (Authority District Routine Order # 157 (b))
2. Henceforth no merchandise or tickets will be sold on credit.
3. As there does not appear to be any regulation prohibiting the purchase for cash of Canteen Tickets (which are redeemable for cash), until further notice Personnel who so desire will be permitted to purchase books of tickets for cash, in order to obviate the necessity for carrying sums of money on York Island.

LEAVE AND FURLOUGH - GENERAL

1. With reference to Routine Order No. 62, leave or furlough must be restricted to Canada. Leave to travel abroad will not be granted. (Auth. C.I.C.F. R.O. 155) Leave and furlough is a privilege and not a right.
2. It must be clearly understood that leave privilege is not cumulative and that no assurance can be given that leave not taken now will be available at a later date.
3. All leave and furlough authorized by C.I.C.F. Routine order 62, 26th October, 1939, will be completed as quickly as possible.
4. Leave and furlough should therefore be granted to as large a percentage of total strength of units at one time as possible. Due consideration however should be taken to ensure that essential duties are not interfered with and that sufficient personnel are available to perform these duties.

9. RECOVERY OF DEBTS CONTRACTED BY PERSONNEL (C.A.S.F. R.O. #544)

a. To maintain the high standard and good reputation of the Active Militia generally and of the Canadian Active Service Force in particular, it is essential that all personnel pay their accounts with tradesman, etc., and all legitimate debts as soon as possible.

b. Letters received at National Defence Headquarters show that in many cases units and individuals have proceeded overseas without paying all accounts before leaving Canada, or that individuals who have enlisted are using the fact that they are soldiers as an excuse to evade payment of legitimate debts contracted prior to enlistment.

c. The following points are to be borne in mind:-

- (1) The Department will take no responsibility for the debts contracted by units or individuals.
- (2) A member of the C.A.S.F. is subject to the jurisdiction of the Civil and Criminal Courts in the same manner and to the same extent as all other subjects of His Majesty, with the exception that no execution can be taken against his person, pay, arms, equipment, regimental necessaries or clothing.

d. Each individual is responsible at all times that sufficient money is kept to his credit in his bank account to pay

all cheques issued by him. If he has not sufficient funds to his credit in the bank on which his cheque is issued, ~~if~~ he is liable to be prosecuted under Section 405 of the Criminal Code, in addition to any military proceedings.

c. Officers Commanding are responsible that all legitimate debts of their units are met, and that they draw to the attention of all under their command the necessity for paying their individual debts, especially when moving out of a locality.

1. Replying to your letter 4th March 1940. File 5-11-19.

2.(a) 85th Bty. Remonell

By H.Q. M.D. 11 Circular V 2-1-26-36 dated 20th November, 1939, O.C. York Island is authorized to grant 7 days leave every three months to personnel of this battery. This was a subject of correspondence between O.C. York Island and the B.C.C. about relief for this Battery and the B.C.C. recommended to H.Q. M.D. that instead of relief, this Battery should be granted 7 days leave every three months, which was approved by H.Q. M.D.

(b) Under this ruling practically every man has had seven days in December or January and are now entitled to another 7 days which is being granted as rapidly as possible.

(c) The only exceptions are men who-

- (i) whose homes are too far away to be reached in a week. e.g. Calgary or Winnipeg.
- (ii) Men who joined other Regiments (e.g. B.C. Dragoons) at the outbreak of war, but were later transferred to this Battery.
- (iii) These amount to the 5 O.R.s mentioned in our Telegram # 407 dated 28th February.

3.(a) #5 Troop, 3 S/L Bty. Detachment

This detachment was sent up for three months (some arriving 12th Dec. balance 19th Dec.) and the instructions were that these men should be relieved by other men on 12th and 19th of March. On returning to Vancouver they would obtain leave.

(b) All of these men have served six months and are now entitled to two weeks. See our telegram # 407 dated 29th February.

(c) Apparently this detachment cannot be relieved by another detachment owing to shortage of personnel at Vancouver, because if you cannot replace three men sent down sick it is obvious you cannot replace 1 Officer and 33 O.R.s

(d) Under these circumstances I asked you for permission to grant these men two weeks leave which, I understand, is approved.

(e) I request that you advise me whether it is intended to maintain # 5 Troop permanently on York Island. If so it will be necessary to give me authority to give them a weeks leave every three months in a similar manner to the 85th Bty. Bty.

(f) I would like to keep them as most of them are rapidly becoming trained gunners on 4.7 guns, and I would have to break in a new detachment if it is sent up.

- (g) At present I have 24 O.R.s left in § 5 Troop at York Island. Three O.R.s are down under treatment and six O.R.s have been transferred to Vancouver and elsewhere and have never been replaced by 3rd S/L Bty.
- (h) I propose to send them on two weeks leave in three parties commencing 12th March. This will complete their leave in about seven weeks.
4. Detachment 2nd Bn. (MG) C.S. Regt. The question of relief for this detachment was dealt with in a letter to you last week.
5. Detachment 10th Fortress Sig. This detachment has just been relieved .

DENTAL TREATMENT

1. Referring to your letter of 1st March 1940 file 5-11-6-3, enclosed are letters and reports on the following.

K.22106 Cmr. Wadham, R.E. 3 S/L Bty.
K.19051 Cmr. Carlson, S. 80th Wvg. Bty.
K.17088 Cmr. Beaulieu, J.L. 80th Wvg. Bty.

2. These are examples of what I have been trying to bring out in the last series of letters apparently without success.
3. By the regulations Coast Defence Personnel may be Category "A", "B", "C" or "D". This may be alright in a well constructed concrete Fort with warm living quarters and proper sanitary facilities but it does not apply, at present, to York Island, with a cold damp climate, very windy and wet, unlined draughty sleeping bays, very primitive and inadequate sanitary facilities and extremely poor light.
4. Under these conditions men sent up here who are used to good living conditions sicken rapidly and the weak point of most of them is teeth.
5. When a man parades before the M.O. with toothache he can get painkiller for a while, but if the toothache continues there is nothing else for it but to send him to Vancouver.
6. Out of the last twelve reinforcements that have arrived in the last three weeks one man is back in Vancouver with toothache and another on his way, while a third is being stalled off, but will probably have to go soon.
7. The Medical Corps at Vancouver has been undermanned, consequently the men have had to wait a considerable time between appointments. The O.C. York Island wonders why it takes so long to fill a few cavities and writes about it as it runs the Gun Crew short.

The men don't like it because the B.S.M. looks on them as a godsend to do continuous fatigues between dental appointments. The Brigade Major wonders why so many York Island men are in Vancouver and writes dirty letters. As a result everyone gets annoyed except the above mentioned B.S.M.

8. It seems to me that the only way to prevent this continuous friction about dentistry and other sickness is for a careful examination by both a Medical Officer and a Dental Officer before anyone is sent to York Island. No one should be sent up unless perfectly fit both medical and dental.
9. The first detachment of 50 O.R.s who came up on Aug. 6th 1939, have had far less sickness than later reinforcements, even though all they had was an examination by Major Beaulieu and Lieut Ganshorn. After some months on the Island a

certain amount of Dental trouble developed but it has not been as serious as later drafts.

10. In the meantime the men are here, and I would suggest that a dental Officer and equipment be sent up here to fix them up. One difficulty is the lack of accommodation, but we will have to find accommodation even if we have to build a hut for him. This will be a lot cheaper than sending a steady stream of men back to Vancouver.

1. At 1130 hrs on 9th March, 1940, the Fort observed a vessel moving from west to south-east on Johnson straight. The attention of the Examination vessel was drawn to the vessel.
2. The Examination Vessel signalled the ship to stop and on failure to do so, signalled the fort to fire a Bring to Round.
3. No. 2 Gun was the only one able to bear on the target (No. 1 being unable to do so for a safety reason) No. 2 Gun had a misfire but after the specified time, the cartridge was withdrawn and a new cartridge substituted and fired at 1145 hrs at 4000 yards.
4. The vessel failed to stop, so the examination vessel signalled for further rounds.
5. Two more rounds were fired which appeared to fall in front of the vessel which disappeared out of sight heading south.
6. The O.C.O. reported the failure to stop to Esquimalt by telegram.
7. The vessel was chased by the other examination vessel, H.M.C.S. "San Tomas", which happened to be at Kelsey Bay. She was chased for 15 miles before being overtaken. Her name was "GTS 6". There were some suspicious circumstances about the case which are being fully dealt with by the Navy.

FIRE PREVENTION

1. As you saw during your inspection of this island, the island is covered with slash and fallen debris which in dry weather would take fire and be very difficult to put out.
2. The worst situation is in front of the fort and along the road leading to the fort.
3. Due to the prevalence of westerly winds during the summer, a fire once started from any cause, could easily develop into a conflagration which would destroy the fort and camp, especially as there is a considerable amount of ammunition stored in the fort.
4. The fallen timber should be cleared, useless material burned and good material cut up for use as firewood on the island.
5. Proper fire pumps and hose should be supplied for the garrison.
6. This matter has been brought to the attention of the D.F.O. personally several times, both by letter and interview, but so far nothing has been done.
7. The season for burning and clearing will soon be over, and I should suggest that you bring the matter to the attention of the D.O.C. personally, so that action could be taken immediately to abate the fire risk.

BROKEN GLASS

1. I hereby certify that the window in the observation post was broken on Active Service as follows:
2. During a severe westerly gale a window was blown in probably due to a defective catch. The glass in the window was cracked in falling. The window was replaced and later on the cracked glass was shattered by the concussion of firing the 4.7 gun.
3. The smaller window glass was broken:
 - (a) By flying rock during blasting to clear the camp.
 - (b) Some of the putty in the new window dried and fell out leaving no protection for the glass, and as several panes fell out in consequence, I had no putty to replace the defective putty.
